Neto denies Walcott joy

Substitute Pedro Neto cancelled out Theo Walcott's second-half goal for Southampton to earn Wolverhampton Wanderers a 1-1 draw in the Premier League at Molineux, here on Tuesday.

A double-save on six minutes by Alex McCarthy from Raul Jimenez and Leander Dendoncker set the tone for a fine performance from the Southampton goalkeeper, while Walcott brought a good stop from Rui Patricio at the other end.

The on-loan Everton forward Walcott, netted for the visitors for the first time since January 2006, early in his first spell for the south-coast club, to give them the lead in the 58th minute at Molineux on Monday.

Pedro Neto came off the bench to equalize in the 75th, turning in a rebound after Raul Jimenez's shot came off the post.

Stuart Armstrong then dragged a shot just wide after a flowing Saints move before Daniel Podence's flicked header for Wolves brought an even better save from McCarthy.

Podence threatened for the hosts again early in the second half but Saints broke the deadlock on 58 minutes when Che Adams drilled a low cross for an unmarked Walcott

to score.

It was Walcott's first league goal for Southampton in almost 15 years. Walcott then fired wide when clean through and, with 15 minutes left, Wolves made him pay.

A sumptuous turn and low shot by Jimenez hit the woodwork, but Neto made no mistake with the rebound.

Southampton remain fifth on 17 points, while Wolves are ninth, with 14 points.

Bilbao routs Betis

MADRID: Athletic Bilbao comfortably defeated Real Betis 4-0 to move further away from the relegation zone in the Spanish league. Athletic got on the board with an own goal by Victor Ruiz in the ninth minute, and Ander Capa added to the lead before halftime. Iker Muniain scored in the 59th and Alex Berenguer sealed the scoring in the 68th. Betis goalkeeper Claudio Bravo had to make a few good saves to keep the hosts from an even bigger win at San Mamés Stadium in Bilbao. The result moved Athletic to eighth place. It was just two points above the relegation zone entering the match. Real Sociedad leads the league with 23 points, three more than second-placed Atlético Madrid, which has two

Palace, Wolves stumble

LONDON: Wilfried Zaha had appeared in each of Crystal Palace's last 59 games in the English Premier League stretching back to February 2019. Conor Coady hadn't missed a minute of Wolverhampton's 84 league games since its promotion back to the top division in 2018.

The two mainstays were unavailable while they isolated during the coronavirus pandemic and that took its toll on their teams on Monday.

Palace was toothless in attack without Zaha, who tested positive for COVID-19 ahead of the game, and slumped to a 1-0 loss to a Burnley side that hadn't previously won in the league. Chris Wood scored in the eighth minute. Coady was missing for Wolves, having had to train in isolation after discovering he inadvertently came into contact with somebody who tested positive for the virus. With fellow center back Romain Saiss also out after contracting the virus, Wolves switched to a four-man defense for the first time since May 2017 - before the arrival of current coach Nuno Espirito Santo - and was unimpressive until a late rally earned a 1-1 draw at home to Southampton.

England all set to tour India for full-fledged series

The Board of Control for Cricket in India (BCCI) president Sourav Ganguly on Tuesday confirmed that England will tour India for a full-fledged series of 4 Tests, 3 ODIs and 5 T20Is early next year. England's limited-overs tour, earlier scheduled for September-October 2020, was postponed until January 2021 due to the novel coronavirus lockdown.

"England is touring India for four Test matches, three ODIs, and five T20Is, it is easy to have bilaterals as there are just two teams, we have to keep assessing the situation, a lot of people are talking about the second COVID wave, we have to be careful," Sourav Ganguly said during a virtual press conference organized by Livingguard AG.

Commenting on the 14th edition of the Indian Premier League, Ganguly said: "We are trying to have the next

IPL in India, it's a tournament for India, I always tell people that they need to be here to see what IPL means to India."

"Team is in Australia, they reached on November 11 (13), they will finish quarantine today, the team is in Australia, they will be starting cricket. Australia does not have a number of COVID cases, boys are ready to get on to the field," Ganguly said when he was asked about the upcoming India-Australia series.

India's tour of Australia will begin with the 1st ODI in Sydney on November 27. They will play the second ODI at the same venue two days later before moving to Canberra to play the final ODI and the first T20I on December 2 and 4 respectively.

The players will then come back to Sydney for the final two T20Is on December 6 and 8 respectively. The Test squad players meanwhile, will play two 4-day tour matches in Sydney before the start of the Test series.

Lewis Hamilton set for knighthood

Most successful grand prix racer of all time and the only Black driver in Formula One Champion

The seven-time Formula 1 champion, Lewis Hamilton is all set to receive knighthood in New Year's Honours, for his achievements on and off the track. Lewis Hamilton is set to get the honour after UK Prime Minister Boris Johnson intervened and made a personal recommendation, according to the Daily Mail. There is no denying Hamilton's greatness in the sporting world but his



tax status in the UK was seen as a hindrance to knighthood, according to the report.

Hamilton, the most successful grand prix racer of all time and the only Black driver in F1, sealed a record-equalling seventh world title with his victory in Turkey this month.

Meanwhile, former world champion Damon Hill had said that Hamilton deserves the knighthood for his achievements on and off the track. Hamilton has used his platform to campaign for racial equality, diversity and sustainability.

Stirling Moss, Jack Brabham and Jackie Stewart are the other Formula One racers to have been knighted.

Chennaiyin down Jamshedpur

As Thapa becomes the first Indian goalscorer this season

Much had been made of the fact that there was yet to be an Indian goalscorer after four games. Anirudh Thapa took barely a minute to set that right. Lallanzuala Chhangte missed a chance to score in the 20th minute. His first touch, as he received Crivellaro's excellent pass, took the ball away and the subsequent effort was pushed behind by Rehesh. But he made

amends five minutes later, drawing a push from Isaac Vannalsawma inside the box and winning a penalty. Gonçalves did not make a mistake from the spot.

Chennaiyin enjoyed a spell of domination soon after the second goal. With Hartley off injured, Jamshedpur's defence looked to be there for the taking. But a familiar face had different ideas. In the 37th minute, Valskis headed in Jackichand Singh's cross and reacted with folded hands, almost as if he was apologising to fans of his former team.

The second half started off where the first had left off with both teams creating chances in the first ten minutes. Chennaiyin forward Jakub Sylvestr wasted the best of them, firing a Chhangte cross over the bar. At the other end, Jamshedpur were pushing hard for the equaliser. Stephen Eze should have headed home in the 64th minute but missed the target while Jackichand failed to capitalise on an error by Chennaiyin keeper Vishal Kaith four minutes later. Jamshedpur were left to rue their misses as Chennaiyin held on for the win.

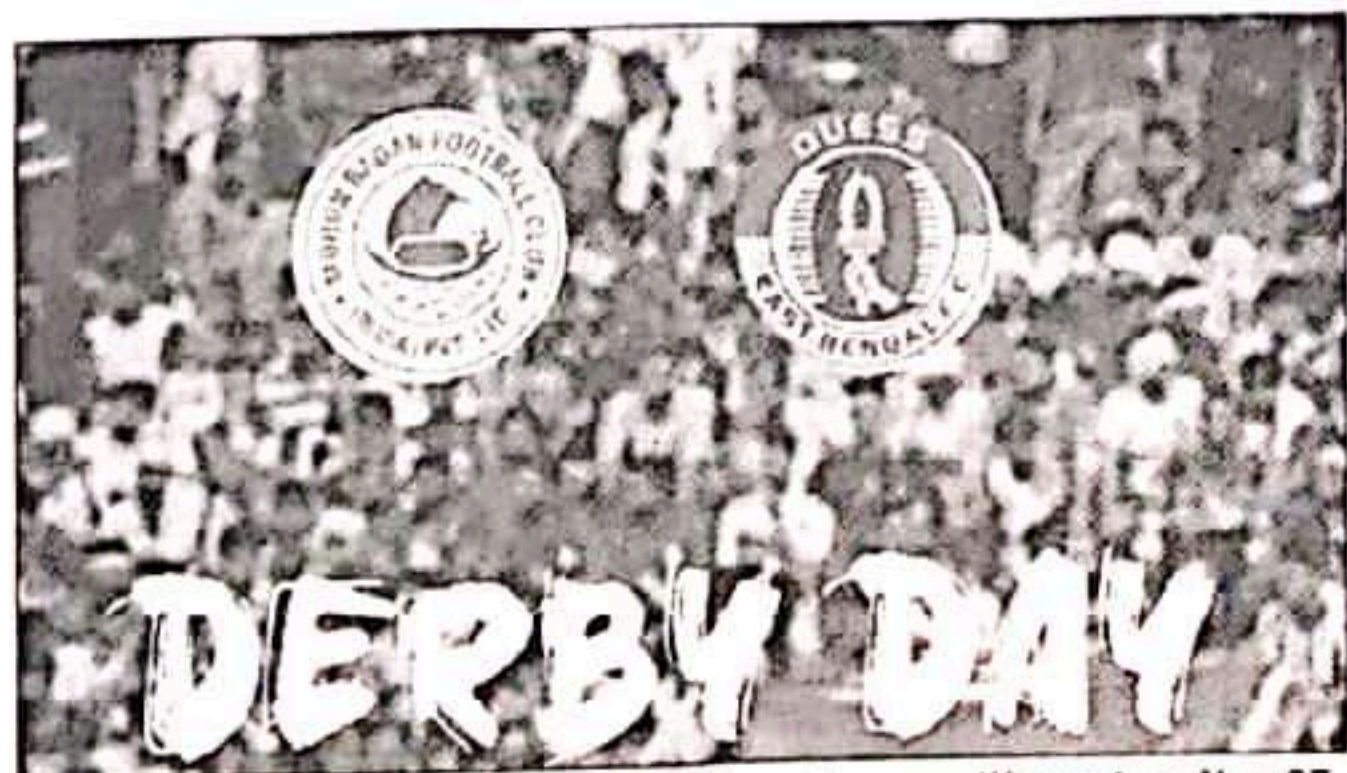
Kolkata Derby draws attention
